

#### Caregiving – A Significant Challenge of Today's Sandwich Generation

As employees' parents and grandparents age and deal with health and financial issues, odds are good these employees will have to play a part in providing care. Or begin planning for future care themselves.

68%

**68%** of ARAG members have a living parent or grandparent today.<sup>1</sup>

61%

**61%** of the employees in the U.S. who are caregivers have caregiving duties to children, parents, family members or friends.<sup>2</sup>

54%

**54%** of Americans considered as part of the sandwich generation have a living parent 65 or older.<sup>3</sup>



Most Employees and Retirees Aren't
Prepared to Become Caregivers or to
Receive Care for Themselves

Having to shoulder caregiving responsibilities is already a cause of significant stress and taking on the caregiver role without a plan in place can create a major disruption in the caregiver's life.



#### **Financial Needs**

The median cost across the U.S. for a semi-private room in a nursing home facility is \$8,669/monthly.4



#### Time

Caregivers spend an average of nearly **26 hours/week** providing care.<sup>5</sup>



#### **Legal Needs**

The average cost to prepare Advance Directives (Living Will & Durable POA) is \$957.6




