Dear Tribal Communities and CSU/UC Staff,

This correspondence is soliciting applications from qualified tribal and University of California or California State University representatives to serve on the UC or CSU NAGPRA Repatriation Oversight Committees. Respectful repatriation rooted in meaningful tribal consultation is required by the [California Native American Graves Protection and Repatriation Act](#) (CalNAGPRA). CalNAGPRA requires that the UC and CSU establish both Campus and Systemwide repatriation committees. These committees are platforms for passionate advocates to ensure legal compliance, cultural respect, and the decolonization of both the UC's and CSU's repatriation practices.

The Committees are composed of both UC/CSU and tribal representatives who are reviewed and nominated by the Native American Heritage Commission (NAHC) before appointment by the UC/CSU.
